Affiliation Agreement

The National Osteoporosis Foundation NORTH DALLAS Support Group
(Name)

We, the undersigned, do hereby establish the National Osteoporosis Foundation

NORTH DALLAS (name) Support Group as an affiliate of the National Osteoporosis Foundation (NOF) and, as leader(s) of this support group, pledge to support the goals of NOF, primarily by:

- Providing accurate, up-to-date osteoporosis information to patients, and when appropriate, family members and care providers; and
- Creating opportunities for affected persons to share concerns, problems and coping strategies regarding their disease management.

We pledge to adhere to the following operational guidelines:

1. Our support group will be free and open to the public.
2. We will use the NOF logo and name in the following format only: **National Osteoporosis Foundation** (name) **Support Group.**
3. The NOF name and logo cannot be used on any product directly or indirectly suggesting endorsement or in conjunction with any other name or logo. No alteration, redesign, modification or adjustment can be made to the NOF name and logo without prior written approval of NOF.
4. We will maintain a confidential list of group participant's names, addresses and phone numbers for use by NOF only for correspondence, informational and membership mailings. Support group participants are notified of the list's purpose and are not required to sign in. This list is the sole property of NOF and will not be provided to any other organization.
5. We are responsible for our own operations and recognize that the Affiliation Agreement in no way authorizes our support group to act as general agents of NOF.

6. We will not enter into contracts or agreements, or conduct any activities, including taking public positions which are inconsistent with the Foundation's mission and not-for-profit or tax-exempt status.
7. We will not endorse any product, corporation, facility, treatment, person(s) or group. This includes the selling of any product at any support group activity.
8. We will not participate or intervene in political campaigns on behalf of (or in opposition to) any candidate for public office, or engage in substantial lobbying activities.
9. Monies received by the support group will be forwarded to NOF headquarters in Washington DC for recording and acknowledgment. All NOF funds are managed in accordance with the policies and practices approved by NOF's Board of Trustees.
10. If we decide to disband or withdraw from the support group program we will notify NOF in advance of discontinuing support group activities. We understand that by withdrawing from *Building Strength Together*®, we would forfeit all rights and benefits of affiliation, including use of NOF's name and logo.
11. NOF has the right to revoke the *Building Strength Together*® Affiliation Agreement if at any time a support group acts in a manner that is contrary to the Affiliation Agreement, or to the goals, objectives and general supervision of NOF.
12. NOF will review the operations of each support group and will require annual activity and financial reports to be completed by support group leaders.
13. To assist in the promotion and awareness of support group activities, each group will send copies of all written materials, i.e. promotional material, flyers, etc. to NOF's Department of Patient and Professional Education.
